

FEED APPLICATION RATES

Pesto feed supplement is to be mixed at a rate of 2% of the dry weight of the feed (e.g. 2 lbs per 100 lbs)

HORSE & CATTLE	2 lbs per 100 lbs
CHICKENS - DRY GRAIN	1/2 tsp per cup grain
TURKEYS, GEESE, DUCKS	1/3 tsp per cup grain
HOGS & SHEEP (FULL GROWN)	2 lbs per 100 lbs
HOGS (MEDIUM SIZE)	1 lb per 100 lbs
BUFFALO & ELK - DRY GRAIN	2 lbs per 100 lbs
DOG (LARGE) - DRY FOOD	1 tsp per 2 cups
DOG (SMALL) - DRY FOOD	1 tsp per 1 cup
DOG - MOIST CAN FOOD	1 tsp per 16 oz can
CAT - DRY FOOD	1/3 tsp per cup
CAT - MOIST CAN FOOD	1/8 tsp per can

SEQUESTERING GAS EMISSIONS

Specifics of what Pesto Feed Additive can do in sequestering gas emissions:

- Ability to suppress livestock odor internally and externally, in feces and manure (also killing fly larva in the animal waste - and killing flies in Dairy barns and animal confinement buildings of all types)
- The extraordinary large pore volume of Pesto Feed Additive provides the ability to suppress odor by binding-up and holding any type of VOC gas emission. Pesto Feed Additive has historically been used in cattle feed; as a "buffer" to reduce gas and bloating and as an anti-caking agent, allowing greater "break-up" and absorption of feed in the intestine.
- Pesto Feed Additive breaks up and desiccates molds that develop in stored feeds. These Aflotoxin/Mycotoxin in molds are known to increase the gas bloating in livestock.
- The Pesto Feed Additive pore volume also makes it a more effective "carrier" for any selected microbes used to increase nutritional values including the type of microbes used to reduce methane gas emissions.
